**KNOWN ALL MEN BY THESE PRESENTS:**

***Battambang Institute of Technology (BIT)***, Cambodia, which is located at Address: Rumchek 4 Village, Rattanak Commune, Battambang District, Battambang Province, Kingdom of Cambodia, hereinafter referred to as BIT, and represented in this MoU by its Director, Mr. Ouk Davandy.

*And*

**Nommensen HKBP University**, Indonesia, which is located at Jln. Sutomo No. 4A, Medan, Sumatera Utara, 20234, hereinafter referred to as NHU and represented in instrument by its rector, Dr. Ir. Sabam Malau.

**WITNESSETH**

**WHEREAS, BIT** is a Public Administrative Institution under the Ministry of Labour and Vocational Training, Kingdom of Cambodia for the technical and vocational education and training in the areas of Electricity, Electronics, IT and Graphic Design, Auto Mechanics, Agriculture Machinery, Civil Engineering, Air-conditioner.

**WHEREAS, NHU** is a private Higher Education Institution with one campus in Medan, North Sumatera, Indonesia, and provides Graduate/Bachelor/Diploma-level education and training and certification in the areas of Master of Management, Master of English Education, English Education, Indonesian Language Education, Germany Education, Economic Education, Civic and Pancasila Education, Christian Education, Mathematics Education, Physics Education, Agri-ecotechnology, Agribusiness, Agricultural Technology, Accountings Program, Management Program, Developmental Economy, Cattle Breeding, Business Law, Constitutional Law, Criminal Law, Civil Law, Civil Engineering Program, Mechanical Engineering Program, Electrical Engineering Program, English Department, Music Department, Business Administration Program, Public Administration Program, Medicine Education, Medicine Profession, Psychology Department, Secretary Program and Tax Administration Program.

**WHEREAS**, BIT and NHU have complementary objectives and a mutual desire to collaborate in a number of areas to pursue common educational and human development.

In consideration of the above premises and covenants hereunder provided, both parties to this Memorandum of Understanding (MoU) agree as follows:

1. To collaborate in undertaking programs, projects, and other related activities whenever and wherever feasible opportunities present themselves;
2. To exchange scientific materials, publications, and information;
3. To execute separate agreements in writing for any particular undertaking jointly implemented, wherein sharing of responsibilities shall be specified and approved by both parties.

This Memorandum of Understanding takes effect upon signing date by the authorized representatives of both institutions, and remains in force for a period of 3 (three) years, subject to amendment at any time by mutual consent. The effect of the agreement will include all departments, offices and education and training institutes and centers under both parties. The said agreement shall be automatically extended for an additional period of 3 (three) years at each expiration date, unless either party gives written notice to terminate the agreement at least six months prior to the expiration date.

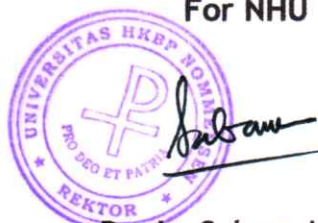
